SWEARING IN OATH

I Samuel Robert Ludwick solemnly affirm by all that is sacred and righteous, that my testimony here is given freely and without coercion, and this is the truth, the whole truth, and nothing but the truth, so help me God.

Your Honors Judge Walsh, Judge Cleverly, Chief Counsel Steele, and Judicial Commissioners,

My Name is Samuel Robert Ludwick. My Education consists of an Associate of Science Degree in Architectural Design and Construction Technology, graduating with a 4.0 grade point average, an Associate of Arts Degree in General Education, graduating with a 3.7 grade point average, at Miami Dade College. I was admitted to Miami Dade College through the IASA Program, “The Improving Schools Act” of 1994. I had to complete full Academic Testing and go through a substantial amount of inoculations to get into the program. I also completed (3) three years of a Bachelor of Science Degree in Construction Engineering at Florida A&M University, I had to stop going to school after my mother passed away in 2001 due to trying to work, go to school, deal with my mother’s passing, being gang stalked, and suffering from “Electronic Intrusion”. So, unfortunately, I never completed my education in

Construction Engineering, due to the Attack by Gang Stalkers, and the Electronic Intruders. Throughout my Testimony you will see that the Evidence is there to find exactly which Contractors are Attacking me, and many others in Europe according to Dr. Hildegard Staninger, who has many Clients in Europe. She stated the same organizations, and Companies doing this to me, are also doing this to Citizens of various Nations, and Societies in Europe and around the World.

I began my Career in Architecture, Engineering, and Construction Management at Miami International Airport as an Architectural Designer, Draftsman, and Construction Manager with an Architectural firm which Contracted for Dade County Aviation Department. I received the job through the job placement center at Miami Dade College. In order to do the Construction Inspections at Miami International Airport I had to get Confidential Clearance from the FBI, the United States Postal Service, and The Dade County Aviation Department, to manage Secret Construction Projects at the Airport, for the Security sections located under the Airport, to install Security Devices on the Doors, to Complete the Layout of the Facility to update the Restrooms for Disability Access in accordance with the new 1995 Dade County Building Code after Hurricane Andrew, which had just been released. We also completed a project for the United States Post Office, also located Under their Facility, to inspect for Bomb making materials, drugs, and any other Criminal Substances. I have also worked as a Senior Engineering Technician for an Engineering Firm in Fort Lauderdale, Florida, a Construction Manager for Various Construction Companies, and an Instructor for (2) Two separate Technical Colleges in Fort Lauderdale, Florida. While working and going to school I received my General Contractors License for the State of Florida and was Principal of my own Design/Build Company and went into partnership with a Real Estate Broker who was a friend of my family and had known since I was a child.

I have done substantial Volunteer work for several organizations including Broward County Health and Human Services as an Assistant Instructor for the TRY Center for at risk youth, Transition Incorporated as a volunteer at Turner Guilford Knight Prison to help inmates find food, clothing, shelter, and employment upon release to reduce the recidivism rate, Habitat for Humanity to help build homes for disadvantaged families, Vice President of the Associated General Contractors of America to help rebuild homes after hurricane Andrew for disadvantaged families, and Christ the Rock Community Church completing Design and Construction projects. I have Donated to several charities including UNICEF – The United Nations Children’s Fund, IFMJ – The International Fellowship of Christians and Jews, The American Federation of Police, The Florida Sheriff’s

Department, PACTS International, Targeted Justice, The International Tribunal for Natural Justice, The American Society for the Prevention of Cruelty to Animals, and many others...

I am being victimized by Electronic Intrusion through Remote Neural Monitoring, and Remote Influence of my Central Nervous System (brain and spinal cord), and Peripheral Nervous Systems (somatic and autonomic) causing involuntary body, and brain processes from Wireless Neural Electromagnetic Frequency Signals directed to unlawful implanted Nanobiotechnology (Mesogens). These Frequencies are Trafficked to other people and organizations for Remote Influence and Remote Neural Monitoring for their Licentious, and Sadistic Pleasure, as well as hiding the fact they are experimenting, and implementing Control Technology, therefore Human Trafficking, and Sexual Abuse. The United States Patents for this Technology go back to the early 1970's and can be easily researched on the U.S. Patent website. The intent is Remote Human Torture and Sexual Abuse and attracts the most abominable species of individuals on the planet. The victim is a plaything to their Electronic Captives, the same way a child is a plaything to the sick pedophile in Child sex slavery. The electronic Intrusion that accompanies organized stalking is also known as covert electronic intrusion or harassment and the perpetrator uses remote influence as assault and battery in their menu of depraved sick crimes. These people are the most loathsome Cowards that have ever existed in God's creation on the face of this planet. Their only purpose is for wickedness and evil. Their assailment is always covertly effectuated, many of these criminal organizations have successfully destroyed their targets, called Targeted Individuals by the government, isolating the target from family and friends, financial ruining them, and causing utter chaos in their lives and confusion of their thought process. I like another term to describe myself a "Victim of Terrorism", and these Terrorists, the most horrifying terrorists in society. But now the tables are starting to turn through the legal process, public announcements, and public awareness. These Terrorists will be exposed worldwide as the predatory psychopaths and reprehensible mentally decayed rabble which they are. There are many names for these crimes, and many programs of these crimes.

These crimes are outlined in many publications, websites, periodicals, and research papers by Scientists, Medical Doctors, Professionals from Government Agencies, and Research Groups, which are easily researched on the internet. The list is endless, and the people of the world need to do their research. A good place to start, and to find all the Evidence, and research, patents, etc... is Targetedjustice.com, targetedevidence.com, and PACTS International. These Electromagnetic Frequencies coming into my head, torso, and extremities are associated with organizations, schools, colleges, and universities discovered in an Investigation by Melinda Kidder, Private

Investigator, and Dr. Hildegard Staninger, Industrial Toxicologist both highly respected professionals in their fields. Their Professional Reports are in Evidence to the Tribunal showing I have (11) Eleven Frequencies coming into me. The following FCC call signs, and organizations are licensed for these Frequencies WND218 – Spectrum Holding Inc., in Ocala - Real Party in Interest is Allegro Capital Investors of India and Tulane University of Louisiana, both sending the same Frequency into my Body, WND207 – Nicholls State University, WFD423 – Indiana (Ball State) University, WHR854 – California State University, WNC980 – Independent Spectrum Sarasota, LLC, WNC908 – Colorado State University, WFD423 – Ball State University, WND242 – Dallas-Fort Worth Hospital, WHR624 – University of Utah. There are (2) two signals which have no FCC Universal License, described as no hit signals. The first is 4827.448 Mhz which is a frequency assigned to a “Kernel” in which Wright State University is involved, as well as IBM Cloud, and Northrup Grumens/NEC, which is the Core component of an Operating System, and designed for real time wideband signal detection. The other signal which has no FCC Universal License is -38.05 Mhz. The Spectrum Analyzer used to analyze these signals has detected they are being sent into the Nano-Technology (Mesogens) at Frequencies as high as (6) six Gigahertz with Decibels as high as -118 db (decibels) which at the time seemed mild compared to what I feel most of the time, which is extremely high and can be considered attempted Murder

I have substantial Medical Records, Doctors Reports, Hospital Reports, and Medical Imaging - MRI's & MRA's, Bone Scans of my Entire Body including my Spine, Central Nervous System, and Brain showing Severe Injury. I also have Eyewitness testimony to violent physical manipulation of my head, torso, extremities, Eyes, and Jaw as well as eyewitness testimony of sleep deprivation. All Physical Manifestations are through the manipulation of my Central, and Peripheral nervous systems by the Electromagnetic Signals being sent to the Nano-Technology (Mesogens) throughout my entire Body. Causing Substantial Severe Injuries to my Spine (Crippling my Torso, Head, & Extremities), Damage to Central (Brain & Spinal Cord) and Peripheral (Somatic & Autonomic) Nervous Systems, Damage to my Brain – Cerebral Vascular Disorders - Brain Aneurism, Cerebral Hemorrhage, Thrombosis, and Deterioration of White Matter, Rhegmatogenous of the Eyes (detached Retina), Morgellons Disease from the Mesogens throughout my Torso, head, and Extremities, Heart Problems, Lung Problems, Organ Problems, All can be Evidenced through Imaging Records, and Medical Records in evidence to the Tribunal. Dr. Hildegard Staninger will be doing Toxicological Examinations to determine any, and all Additional injuries, and provide further evidence of these injuries. The Report in Evidence by Melinda Kidder can show the exact placement of the Groupings of the

Nano-Technology (Mesogens), as well as the Numerical Frequency numbers, the Signal Strength, my body temperatures throughout my torso, head, and extremities, the UV Lighting of my Eyes showing Molecular Nano-technology (Mesogens), and Black Spidery Lines throughout my upper extremities. All of this constitutes Attempted premeditated Murder, Torture, and possibly Murder considering I will die prematurely from this, since there is no cure, or way to extract the Molecular NANO-Technology (mesogens) from my Body, and Treason against the United States as they are attacking a Disabled American, they Murdered my Common Law Wife, and my Pet. They are attacking Millions of people across the United States, and Globally. Which I will give evidence to at the closing of this Testimony. There are dozens of other charges which can be brought against these Terrorists as you will hear in my personal story.

In approximately 1999 to 2000 in North Miami Beach where I was living at the Home I was born and raised in to help my Mother through a fatal Medical Condition and due to close proximately to Miami Dade College where I was studying, my wife and I began having problems with my neighbors, hearing footsteps outside my bedroom window, break-ins into our home and vehicles and personal items being stolen, cars parked in the corner of my yard with all windows tinted including the front window. Unusual health problems, such as my eyes, excessive pain in my Lumbar, and Cervical Spine, legs, stomach, and skin eczema which I thought was Eczema at the time but was Morgellons disease due to the Mesogens (Nano-Technology) being put into my system. One morning I woke up to go to work and there was a severe stinging sensation in the back of my neck at the location where the Brain meets the Spinal Cord (the Central Nervous System) which I thought was an insect bite, and the back door to the utility room was wide open. I thought this strange but had no idea what was about to transpire. Of course, later I found out this is the reason for the Gang Stalking to inject you with the implanted Nano-technology, and make you look like your Paranoid Schizophrenic if you go to the hospital or to the police, as well as the Character Assassination to your friends, neighbors, and family. These attacks started happening after a forced traffic collision by a perpetrator. At the Accident scene I was waiting to get off the Highway at Miami Gardens drive where everyone was being directed to exit due to an accident shutting down I-95. As I was waiting for over an hour, I saw in my rear view mirror a car cutting into the line again and again to get in front of the line at the exit. I was at the exit by the time he got to me and he deliberately used his car against my Pick-up truck to push me out of the way so he could cut in front of me. When I looked over at him, he looked at me and laughed, and shrugged his shoulders. As he got in front of me my truck, I hit his rear bumper. We were waiting at least another hour for traffic to get through the red light at Miami

Gardens drive as the exit had a (1) one-mile loop. I knew my truck did not have any damage, so I let him go, and he never came up to me to exchange insurance information. We both drove through the light and away from the scene and I went home. A couple of hours later The Florida Highway Patrol knocked on my door and started harassing me, took me over to my truck to look for damage, which there was none, although he stated there was. He then placed handcuffs on me which were too tight and cut off my circulation. He never read me my Miranda rights, took me to Dade County Jail, booked me, and I stayed there several hours until my wife came to the holding facility with bail money. The Judge in this case charged me with reckless driving, I had to pay the other driver (1) one thousand dollars in restitution and he expunged the records due to the ridiculous claims of the perpetrator and the fact I was going to College and had a perfectly clean Police record. Evidently, they erased all records of anything happening in the case, or anyone being involved. Just recently I obtained (2) two Background Checks, and the Case is nowhere to be found in my past records, and the place where my wife and I moved to after we left North Miami Beach which is Fort Pierce was also erased from my records, and you will see why in the next paragraph. Outside my home I heard someone tampering with the water system under my bedroom window, which I investigated, and they ran away after seeing me. My wife who had Type 1 Diabetes, was being abused by my neighbor, as well as her brother who was staying with us while he contracted for me as a sub-contractor. The neighbor and her Husband threatened us with violence, and to shoot me for no reason at all. I started feeling what felt like very mild electricity going through me as well as my Eyes being forcibly redirected, averted to look at people in ways you normally would not as they were controlling my Optic Nerves, through the Signals coming into the Nano-Technology. While I was praying one day, I actually heard a voice answer me in my head, and everyone who prays to our Lord knows he answers through our hearts in a "Still, Small Voice" , 1 kings 19:12, and through his word, Romans 10:17. I knew right away something was wrong, due to the things that were happening, but of course back then I did not know about this Technology. The Voice of God Program was developed by the CIA in the MK Ultra Program before that time, Robert Duncan, and many other Authors speak of this program, and many, many other programs which were about to be used against my Wife and I.

In approximately 2006 Due to the Stress of the Gang Stalking, the gun violence in the neighborhood, and my neighbor threatening our lives with a firearm my Wife developed Kidney Failure from the Nano-Technology (Mesogens) placed in our Water System and the stress, as she was a type 1 diabetic and went into low, and high blood sugar comas often, and the stress placed on her Body by the Nano-Technology (Mesogens) and the neighbors

was too much. She was placed on Dialysis, and her health was failing her rapidly due to these Terrorists. I had to get her out of that neighborhood and moved to Fort Pierce. I moved to Fort Pierce to start a Design/Build company with a client of mine Ivan "Mac" Mascioli who was an acquaintance of our family since 1967. I was Designing his office building for him, to be built on US-1. I had discussed my problems with Mr. Mascioli before moving to Fort Pierce, and he came up with the Idea of starting a Corporation to complete his Office Building. Shortly after moving to Fort Pierce the Gang Stalking started up again. The Highway Patrol moved into my apartment building, I heard my neighbor constantly lying to the Patrol officers that I was doing drugs which my record in evidence with the tribunal testifies I was not doing Illegal drugs, officers were having Dogs search around my car, and apartment, and of course never found any drugs, or approached me in any way to accuse me of drugs or anything else. This is the reason they have Concealed my Past records of this address in Fort Pierce, and the Criminal Case involving the Florida Highway Patrol. I found out later that this is typical Gang Stalking tactics by neighbors, and Rogue Police officers. I heard noises in the air conditioning ducts, and what sounded like the air conditioning and water system, and these systems being tampered with upstairs for weeks at a time. I tested the air conditioning vents as to the noise and discovered the next-door neighbor was watching us through a plumbing camera. I literally caught his wife making a comment about me when I was in my Bathroom. The next day I went outside and the Highway Patrol officers surrounded her when they saw me, because she said very loudly that I was going to shoot her, and if this was real and not Gang Stalking the Highway Patrol would have looked at my past record and found out I have never had even a Misdemeanor involving any violence what so ever. The Rogue Officers would never have been involved in this. The neighbor worked for a plumbing company and the camera system was advertised on his truck for finding plumbing problems in pipes, and him and his wife were using it to go through the air conditioning vents to try and watch me to set me up for further implantation and frequency signals, as well as character assassination which is typical tactics as all the Evidence from the thousands that have come forward have attested to, and all the whistle blowers have attested to. There was an older gentleman always going up stairs to the apartment above me where the work was going on to install the voyeurism equipment, who I also observed talking to my Client and business partner Ivan "Mac" Mascioli in the office where we would have meetings, and where I worked at times Designing and Drafting his office Building. My Wife and I decided to move again due to the Gang Stalking, I was very worried about her health. When I was leaving Fort Pierce this same gentleman was standing outside watching me pack up the truck and did not seem very happy, I was leaving. Evidently, they had put out a lot of funds into

equipment and Technology the neighbors and the gang stalkers around me used, watching and attacking my Wife, and I.

Due to the Gang Stalking and Harassment my wife and I moved again in 2007 this time to Hawthorne, in Putnam County Florida and rented a house from my brother who was managing the families Motel and RV park. Shortly after moving to Hawthorne the Gang Stalking started again. I saw someone standing behind the garage daily, watching me. I also saw the Neighbor from Fort Pierce next door with several other men watching me constantly. The water pump stopped working so my brother had it repaired, and the repairman said that someone had left the cap to the tank too loose and the pump burnt out. Of course, later I found out they put Nano-Technology (Mesogens) in the Water tank as the same vehicle which followed me in Crescent City, I saw parked in front of our house outside the fence several times. The next-door neighbor threw a 2x4 piece of lumber at the window in the dining room and broke it. Someone broke into our home and stole money, and personal items. Two men tried to break into my bedroom window, and I happen to be home and caught them. My wife wanted me to call the police. I did and the one who tried to break into my house was arrested, and his friend told the police he was the one who broke into my house and stole money and personal items. The feeling of Electricity started to course through my body more often, mostly in my legs and since I was diagnosed with Spine problems from this I went to the Hospital where they administered Steroids to relieve the swelling, which was ineffective. My spine got so bad I had to file for disability with the Social Security Administration Physician and my Primary Care Physician concurred. The Social Security Doctor examined me, and I received disability (3) three years later. My wife was complaining of the same thing saying she felt vibrations in her body. I thought it might be from her poor health due to her Diabetes or kidneys, as I was still unaware of this technology and did not know what Electronic Intrusion, Electronic Harassment, or Satellite Terrorism was, or the gang stalking programs. Our Papillion Puppy who was basically our child for over 12 years was falling mysteriously, and now I know he was getting hit with the electricity too. My wife started having severe pain in her spine too. I took her to the Hospital in Ocala, Florida (3) Times, and they would not do anything about it. Eventually it got to where she had problems getting out of bed, so I would help her up in order to get to the bathroom, or to the kitchen. At her next appointment with her Primary Care Physician, her Doctor referred her to the same Hospital and made sure she had an MRI. They found a Cist in her Spine from the Nano-Technology (Mesogens) and operated but it paralyzed her completely. I would go to visit her every other day and the hospital was not taking care of her properly and I constantly complained. While she

was in the Hospital recovering our Papillion, puppy started screaming one day so I took him to the Veterinarian. I asked for MRI's and they found that he was having problems with his spine also. The only thing he could do for him was give him pain medication. The next day he was still screaming, unable to sleep, eat, or use the bathroom. I could not watch him in so much pain, so I took him back to the Veterinarian and had him put to sleep. My wife took the news extremely bad. After a month in recovery the Doctor at the Hospital and her Primary Care Physician recommended that she go to a rehabilitation Hospital in Gainesville, Florida. I signed the papers for her to go and they did not take care of her properly. At the Rehabilitation Hospital when I would be sitting with her, she would act strange like I do now due to the Electronic Intrusion. They were supposedly treating her for an infection from a hole in her spine caused by a Skin ulcer which the Hospital in Ocala, Florida caused from improper care of her. A month after she was in the rehabilitation hospital, I went to visit her, and she was in the Dialysis center, but she could not move her entire Body, no facial expressions, no body movement at all. I called the administrator of the Hospital and they had the Physician look at her. I heard them call stat to the Dialysis Center and asked them the Problem, of course they did not answer at the time. Her Primary Care Physician who was also her Nephrologist later told me her feeding tube was hooked up to her Dialysis tube. Someone had Murdered her Purposely to hide the evidence of them damaging her spine. I called an Attorney and they told me since I was her Common Law Husband and did not have Court paperwork, I could not sue the Hospitals, her daughter or family did not want to sue because they lived so far away.

In 2012 after the Hospital murdered my Wife, and my Puppy I moved to our family's property in Hawthorne but in Alachua County, Florida. The Gang Stalking, Electronic harassment, and Satellite Terrorism continued. The Electricity from the Electromagnetic Radiation started getting worse, I thought there was a problem with the electricity in the mobile home I was in. I would hear noises on the roof which at the time I thought was Racoons, Rodents, etc... Again, I woke up one morning with a severe pain in the back of my neck, and a needle mark there. The front door was unlocked which I never leave unlocked as Hawthorne is not a safe place to live. The only incident from the neighbors was the Police were called out for the discharging a firearm. I heard them approach my brother though while I was in the next room working on the computer, and they did not know I was there. They were asking him to help them, but my Brother said he would not do that to me. My Brother started to have problems after that and got attacked by a man that came behind him and hit him with a large length of lumber, possibly a 2x4, or 4x4. The Hotel, and RV Park started to have problems due to an

extremely large water bill. We called out professionals to look for leaks, but they could not find out where the water was going to. The Hotel was getting broken into on a regular basis, the laundry room was getting broken into and the washers, and dryers were getting the quarters taken from them. They made sure we could not sustain the business. We went to the City Council meeting to obtain assistance to no avail. My brother and I moved to his house on Silver Lake where my wife and I previously lived in Putnam, County. I lived into a trailer behind his house, and he lived with his daughter and boyfriend. They took advantage of this and started hitting me with more Electromagnetic Radiation than ever before. I thought there was something wrong with the electricity in the trailer again. The Gang Stalking continued. They broke into my trailer on a regular basis stealing personal items. Again, they broke in while I was sleeping and injected me with Nano-Technology, as well as placing it in my water system. They dropped the front of the trailer, so my trailer leaned forward. After we sold the Motel and RV Park I moved to Crescent City, Florida and purchased a Home in a Mobile Home Park.

I moved into Mobile Home #10 at Crescent City Mobile Home Park in Crescent City, Florida in 2013. After I received Computer service, my computer started getting hacked into. Files were being manipulated, they started sending Messages to me on the Desktop. Again, someone broke in and injected me with Nano-Technology, and I heard someone outside one day working on the water pipes, which means it was again placed in my water system. By the time I got outside they were gone. I started having trouble sleeping, they started talking to me when I was praying again at night before I went to sleep. I developed/broke out in a Severe case of Morgellons disease again which I thought was Eczema due to the stress of losing my Wife, and puppy as in North Miami Beach. Eventually I started feeling the Electromagnetic Radiation coursing through my body again, and suffering from sleep deprivation. After living there for a couple of years the manager, Joe, asked me if I would like to sell my Mobile home to the Gentleman, and his wife in mobile home #16. I told him no, but he persisted. I priced the Mobile Home way above Market value to dissuade them from wanting to purchase it. I did not hear from Joe again. About a month later the owner of Mobile Home #16 approached me and accepted the price I quoted. I went and looked at Mobile Home #16 and decided to go ahead and help him and his wife out because they needed a place larger for their Granddaughter. I did not realize that I was being set up for a major Terrorist Attack by the Gang stalkers, and my neighbors, who they were lying to as they lie to all victims of this crime to Assassinate your Character. I had already told the owner and the new Manager to do a background check on me, because I knew now, they were not going to leave me alone, and would continue to attack me. I

also told them not to believe anyone who approached them concerning me because they have lied to my neighbors before. Character assassination is typical for these crimes as can be attested by all victims in these cases, and all Professionals, research, and Whistle blowers. Shortly after I moved into mobile home #16 from mobile home #10 I put a padlock on the sliding glass door because Joe the owner/leaser did not have a key to the door, so I could lock it. Soon after someone took my lock off and put another lock on, so I could not get into that door. My Mobile Home got broken in to, my car was broken into, vandals were constantly stealing and breaking things. Again, I woke up with a puncture mark in the back of my neck and the door left open. I discovered a crack in my ceiling the width of my mobile home after Joe asked to get on my roof to check its configuration for another Mobile Home. I went to Dr. Hough my Primary Care Physician and told him I had been feeling ill, during the examination he found that I had lost over (40) forty pounds due to the Electromagnetic Radiation. My spine Doctor, Dr. Flinchbaugh had possibly talked to the perpetrators as he told me they told him if I filled my prescription, they would put me away, as he was my orthopedic for my spine. He did not say who "they" were. Awhile later my plumbing was vandalized. I heard them cutting a root outside my mobile home. I overheard one of my neighbors Bear say it was due to gossip and rumors about me. The plumber found a root in my drainage system with duct tape holding it in place. It cost me \$550.00 to repair my plumbing. I had heard gossip and slander about me while inside my mobile home from the neighbors having conversations outside, which we always talked in the park as the mobile homes were only (10) ten feet apart, and it was easy to see the street. Basically, Character Assassination again although these people knew I was a very quiet neighbor. Kathy the manager, who Joe had employed after his lease was up with Glorie the owner of the property, constantly called me crazy, trying to get me upset so I would move. Several people treated me with contempt for reasons I did not know. I now know they wanted my mobile home and the perpetrators wanted to continue to ruin my life and reputation. My neighbor knocked on my door one day which he or anybody else in the Mobile Home park never did, and he said he just wanted to talk. I saw his roommate A.J. out of the corner of my eye watching something going on behind my Mobile Home, and then motioning to the gentleman talking to me that everything was O.K., and he stopped the conversation right there. He was distracting me while they were putting a device on my water system. The next day I got a notice on my door from Kathy the Manager that the Water Department had put devices on the Water Systems to measure the amount of water used. I went outside and looked at the device and it was a large plastic device feeding into my Water. I looked at the other Mobile Homes and no one had this

device on their water System. I suspect they were putting additional Nano-Technology in me the same way they did at all the places I lived since before the year 2000. The same suspicious events occurred at all of them. My neighbors from Mobile home 20, Bear, and Kathy the Manager stood outside, and they played as if they were going to shoot me, I ignored the Act and waved to them. I know everyone involved in the Mobile Home Park. One night I heard people outside my mobile home threatening my life and telling me to leave. I called my step daughter immediately and told her if I did not contact her by in the morning to call Law Enforcement in case, they murdered me. They continued telling me they were going to kill me if I did not leave my home. I did not have much of a choice, so I told them to go ahead and shoot. My front window was covered with a picture screen of police officers pointing guns at my mobile home. After several minutes and the officers did not move, I knew it was a set-up. I saw them removing the picture screen the next morning. At night there were sounds of saws trying to saw their way through my mobile home and sounds of them trying to break into my sliding glass door, and windows, Which I found out later was technology like shotgun microphones. They were trying to force me out of my mobile home with electromagnetic devices, Directed Energy Weapons, Sound Casting Devices, etc.... My skin was burning in certain areas, and an immense amount of electricity was coursing through my body. I looked out my window the next morning and saw electromagnetic, and possibly microwave devices all around my home, antennas, wiring, and various unusual devices. I took pictures, but they were erased off my cell phone which was tapped from a remote location. I tried to turn off Bluetooth, and record to no avail as they had locked me out utilizing a password which I could not break. There are still some pictures on my cell phone left of the devices they were using. The pictures they erased can be taken from my SIM card by someone knowledgeable with electronics. As I am disabled, and I held up a sign with the letters ADA (American Disabilities Act). A short time later I heard a gentleman telling them to take down the devices on Sunday night, as I would not be able to call the ADA until Monday morning. That morning the manager Kathy told me she wanted me to come outside. I looked outside and did not see her. She continued to tell me to come outside. When she finally showed herself, I went outside to see what she wanted. Her and a police officer was standing there, When I went up to talk to them the police officer grabbed for my arm and went to pull his gun. I was unarmed and calm. I took Chinese arts, meditation, and Martial arts when I was younger so not much scares me or causes much stress. I turned around slowly and walked into my house. I told them all they want is to take away my home. She called me outside again telling me the police officers were gone, again I suspect Rogue Police Officers. She told me she wanted me

to see the paramedics after what they did to me. Which shows she set me up along with the perpetrator. So, I went outside and let the paramedics examine me in the back of the truck. The paramedics examined me physically and psychologically and told me I was fine and quickly gave me an injection which they said was to help me relax, but I suspect was more Nano-Technology (Mesogens).

The rogue paramedics, and police knew about the entire program of gang stalking and electronic intrusion. That night they were also hacking into my computer, and using the speakers to create various sounds, and voices, as well as creating characters on my computer. There had been several instances of hacking in the past. Possibly the IP addresses of the hackers can be found by a knowledgeable person in computer technology. They continued to tell me to leave my home, so I packed my things to leave. I heard audible voices that evening which sounded like Glorie the owner, Kathy the manager, and the chief of police. The next morning, I went to Winn-Dixie to refill my medication where I discovered my debit card did not work. I told the pharmacist they were chasing me out of my home, and the pharmacist and pharmacy technician told me they already knew about what they were doing to me, which tells me they were lying to the entire town about me to assassinate my character. Even the local Police Department. I was outside checking the damage on my mobile home and Kathy the manager was following me around. As I was checking the sliding glass door, I noticed they had replaced their padlock with the padlock I originally put on. I saw Kathy point this out to the neighbors across the street from me. I got my key and checked my lock to make sure it worked. Later, Kathy and Bear came to my porch and asked me what was wrong as if they already knew about it. I told them I wasn't feeling well, and Kathy stated, "that's EDOM". During my research I found out that EDOM is defined as "Electronic Dissolution of Memory", a term for Electronic Terrorism. EDOM-RHIC defined in Robert Duncans publication and many others. The manager Kathy continued to call me crazy and told me I was incapable of taking care of myself, when I was doing fine. This is typical of Organized Gang Stalking, to discredit the Targeted Individual to get them to kill themselves or be diagnosed as Delusional / Paranoid Schizophrenic. I packed my things and was sitting outside when I heard the owner Glorie tell the Manager Kathy she did not know what to put on my eviction notice. Kathy told her to wait until I moved, and she would deal with it. I am disabled, and it is illegal for them to force me out. After that I went ahead and packed my vehicle and left thinking that would be the end of it, since I did what they wanted. As I was driving out of town on route 17, I heard people talking over a two-way radio, telling

someone to follow me and to pull me over before I reached the city limits. I looked behind me and there was a lady in a red pick-up truck. The talking I heard they called spyware, which they said was put into my car, as I heard them later state. That day I did not let them know I could hear them through their own spy device. She stated "Chief, I am unable to pull him over because he is driving the speed limit". I continued until an SUV pulled alongside of me and motioned for me to pull over in Volusia, County, at a laundry mat on route 17. I pulled over and sat there as I was in immense pain from packing and moving my mobile home. I called my step daughter while I was sitting there. I heard two people talking over my speaker (vibrations). I audibly heard someone talking behind the fence next to the laundry mat and could see him through the fence. I looked behind me and saw the red pickup truck which was following me in the empty lot across the street. They were conversing concerning me. I heard them call each other "Lieutenant", and "Chief". While I was talking to my stepdaughter, I told her exactly what they were talking about. They were listening to my conversation, and once they learned that I was able to hear them they got quiet. A few minutes later a Volusia County Sheriffs car pulled behind me. They walked to my car and told me to get out, which I did. They searched me and asked me why I was parked there. I told them I was leaving Crescent City but did not have the money to get to Miami to where my step daughter is, that someone had changed the password on my bank account by hacking into my computer. They told me to go to Crescent City Police Department and report it. The police department told me to go to the bank and get a statement. I went to the ATM first to double check my account and was still locked out. I went inside and requested a statement. I withdrew all my funds after showing them my ATM card. I went back to the Police Station and they had locked their doors, probably because the perpetrators had discussed this with them. After I left town, I disconnected the cell phone by pulling the SIM card and I heard them on the so-called spyware as they called it, that they lost my signal. The so-called Chief of Police told them to follow me.

I stayed at several hotels over a period of three weeks. I was continuously followed and harassed again in 2016. At one of the hotels I woke up with a red area around a puncture mark. It eventually got infected and I ended up at Hollywood Memorial Hospital. I received intravenous antibiotics. I told them I was homeless due to being forced out of my home and they referred me to an independent living facility. I lived at the independent living facility for two months, where it all started again. While going to the bank and Post Office one day to change my address and set up my bank account a Spanish gentleman deliberately hit my car extremely hard

destroying my right quarter panel. He looked like the same guy who hit me in North Miami Beach several years ago. He called the Police, and since it was caught on a traffic camera at the corner of Miramar Parkway, and State Road (7) seven, they charged him with the accident, and told me to leave. In the accident report which I still have, the Officer in charge put a fictitious Insurance company down for me. For what reason I do not Know. Other cars were hit in the accident also. Neither accident, charges, or Court appearances showed up on (2) two separate background searches of myself. Both I completed on February 2nd, 2019. I even went further and searched all the court records and did a National Security search on myself to no avail. No accidents, no Tickets for the Incidents involving this gentleman, or police officers involved. The searches just revealed that I have no Criminal Background whatsoever. Keep in mind I was a Boy scout from the time I was a Child to the time I was a teenager, I have no Criminal Background, and no Misdemeanor offences. So why the Attacks by the Government? At the Independent Living Facility where I was placed by Hollywood Memorial Hospital Social workers Staff I heard the same people that were outside my bedroom as Crescent City utilizing (V2K) Voice to Skull Technology. They were using the voices of whom they called the Chief of Police, and Lieutenant, etc.... The next-door neighbors were pounding on garbage cans outside my window when I went to bed. On the fourth of July they shot a gun off 15 times right outside my window to see if I would be affected. I was a National Rifle Association Firearms Instructor, and a Competition Shooter in the Boy Scouts, so I know the sound of a firearm verses the sound of Fireworks. They stated they were trying to Rattle me. Evidently, they wanted me stressed out. The next-door neighbors seemed to be involved as because I heard and saw them discussing my situation several times. According to my research Gang stalkers typically get the neighbors involved through character assassination. One time I heard the neighbors discussing with the air conditioner repair men the fact that my mind was being read. The so-called Chief of Police (same voice) stated when he started repeating my prayers to me one night that my mind was being read, and he could see all five senses on the computer, and they would continue doing this the "rest of my Life". I heard continuous voices which seemed to be coming from speakers, as well as Auditory Harassment (V2K) voice to skull technology. Then they started the electrical attack again from Directed Energy Weapons, electromagnetic pulse weapons, and microwave wave weapons. One night they nearly murdered me they were hitting me so hard in my head and chest, trying to get my heart to stop and damage my brain. The Pain and Torture from the Directed Energy Weapons, Microwave Weapons, V2K, the Nano-Technology implanted throughout my Body is Extremely Painful. The Pain is so Extreme that it is

impossible to describe. They did Severe and extreme damage to my Brain, Central and Peripheral Nervous Systems, my Spine, and throughout my torso and Extremities, as my MRA's, MRI's, and Medical Reports can attest to. When I was at a Doctor's appointment in Lowell Davis's office for my Spine, two gentlemen were sitting around me, one sitting next to me, the other across from me. The V2K (voice to skull technology) started talking to me, and it was coming up on his I-Phone and he would follow the directions from his Handler. They would tell him idiotic things to do, and he would do them just to show me the V2K (voice to skull) technology, he had an earpiece in. To let me know that I was being watched, for what reason I do not know as my Background searches attested to. The gentleman went into the back-exit door to talk to someone in Dr. Davis's office and then came out. I have a feeling it was my Doctor because I received injections in my Spine that day, and it was the most painful experience of my life. It should not have been that painful. They did not wait for the Anesthetic to work before they injected me. One day the V2K started telling me to get out of the house and not to take anything with me, as they were subjecting me to an intense amount of electricity, through Directed Energy Weapons. I was unable to stand the immense pain and packed up my most valuable possessions and left, the same as I did at Crescent City Mobile Home Park. The Landladies Sister who is a Military Psychiatrist was parked in the Yard watching me pack up my car and told me to lock the door through the V2K – voice to skull technology. I did not want my land lady at the independent living facility Ms. Foster involved with all this as she was 78 years old and a very kind lady, her sister is substantially younger. I was continuously hit with massive amounts of electricity as I stayed at several hotels, and the V2K auditory harassment continued. I was out of money at this point, and my health was deteriorating rapidly. I called my brother Lee and told him I was homeless and needed help, as I called him from Crescent City when this first started. At that time, I was down to 160 pounds and had lost as much as 100 pounds from the Nano-Technology, the implanted Mesogens, and the Electromagnetic Frequency signals were making me extremely ill, to the point of death.

I left Miramar and moved in with my brother in 2016. I am still presently staying with my brother and sister-in-law. The Electricity continued to course through my body. They had more control of my Central Nervous System at this time, as they continued to cause my head, neck, and extremities to move sharply and painfully, causing severe damage as described in my Medical Records. I did not sleep for over a month due to the continued attack from these Weapons of Mass Destruction. I was having painful cramps in my feet and legs. I did

not know exactly what was happening to me, although I knew I was being stalked utilizing some type of technology. I talked to my brother and he told me about organized gang stalking, utilizing microchip implants. He heard of this on the radio show Coast to Coast, with Derrick Robinson. I started doing extensive research on the subject and have seen several Doctors. The Doctors have done MRI's, Bone scans, X-rays, and an MRA. The Neurologist found a small saccular aneurism off the left lateral distal basilar artery, and anterior cerebral artery severely stenotic due to the Electromagnetic Radiation being used against me. They could not find a microchip probably because they used Nanotechnology, as well as Computer Generated Brain Mapping. The doctors do not want to deal with the cause, they just want to relieve the symptoms, as this technology is unknown to some of the doctors I have seen, and they have threatened or payed off others. My life is being threatened by this, I am slowly dying from the ionic radiation, and constantly harassed with Auditory Harassment 24 hours a day, 7 days a week. The electromagnetic radiation is extensive and constant. My headaches are severe, as well as immense pain in my spine, and extremities. My MRI's reveal they have crippled my Cervical Spine, Lumbar Spine, and Nervous Systems. As of February 2019, they are harassing me through auditory harassment (V2K) voice to skull technology, and extensive electricity coursing through my body continuously 24 hour a day, 7 days a week from the Microwave weapons. Through the Auditory Harassment they are trying to cause Mental Anguish, and Psychological distress utilizing the image of the final moments in the death of all my loved ones, the worst aspects of their deaths which is too terrible to discuss. With the V2K (Auditory Harassment) from Computers, Artificial Intelligence, and Computer Operators, they speak and visualize the most Perverted, Depraved Sexual Elucidations beyond imagination, utilizing past and present people in my life no matter who. They also use various other extremely grotesque Elucidations beyond imagination. Fortunately, I am strong enough mentally to get through this so far, but through my research I have discovered that they are able to get people to take their own lives, and be diagnosed with Psychiatric illnesses, such as Psychosis, Paranoid-Schizophrenia, etc... They through subtle thought manipulation which the victim is completely unaware of, also get people to take the lives of others as in the mass shootings you have been seeing around the United States, more than likely to take away our "right to keep and bear arms" outlined in the Constitution, by turning Americans against Firearms. They control the Brain and all your Nervous Systems, so they can control the desire for Medications which work on the Nervous System, hence the "Opioid" Crisis in America. They now, due to the V2K (voice to skull) technology they cannot be subtle like the first (10) ten years of this, torture me constantly, trying to get me to take my life,

and to Hurt others, for example trying to get me to commit mass Shootings, hit others, commit sexual Acts, take overdoses of my Medications, etc.... They can see and hear everything around me, so they are invading the privacy of not only me, but also my family, and everybody around me. My family and I have put an extreme amount of funds trying to take care of me while I go through this. My family knows me very well and knows that I am physically and mentally strong, so I have handled it to this point, and I have a high moral philosophy, so they believed the events which transpired right away and are witnesses to the outward physical evidence of what was and is happening. I have a Strong faith in my Lord, which is the Main reason I have Gotten through this. He has Prepared me for this my Entire Life, through Biblical Studies, Chinese Arts as in Meditation, and Martial Arts. As I stated earlier it was my brother which pointed me in the right direction as to what was happening to me. They told me they are available as witnesses to what has happened to me and will complete affidavits attesting to the physical manifestations of this. These Terrorists have cost me my entire career, which I went to school for many years to change to a better career. They have cost me my Health, My Life, My Wife, My Puppy, and (5) five homes. I have spent all the Funds that I have received dealing with this since before the year 2000 on places to live, Hotels, trying to escape, devices trying to stop this, Professionals, Attorneys, Private Investigators, etc...

As I stated in the beginning of this Testimony through my research, I have discovered this is Electronic Intrusion, Electronic/Satellite Terrorism utilizing Satellite Weapons Technology, Electromagnetic Pulse Weapons, and Organized Gang Stalking, and many other names. Also, there are many different programs that the Government Agencies, Corporations, and organized Crime has put together to do this to all societies across the globe. As part of my research I traveled 1000 miles to Tennessee to find out whether it was local transmissions or satellite transmissions, and discovered it is satellite transmission as the auditory harassment did not stop or diminish at a thousand miles away. There are many names of what is being done to me. Remote Neural Monitoring, Auditory Harassment, V2K (voice to skull), R.H.I.C. E.D.O.M. (radio hypnotic intra-cerebral control / electronic dissolution of memory), etc... Most of the V2K Voice to Skull is spoken by a computer system, what they call A.I. Artificial Intelligence, which is basically an oxymoron since machines have no soul, or spirit. The computers of course have operators, and programmers which speak occasionally but the computer does most of the talking. The so-called A.I. Artificial Intelligence has no real knowledge, because they have no

understanding, or wisdom, as stated in the first chapter of Proverbs. Everything the A.I. supposedly thinks, is downloaded information which is run by Algorithms. I have United States Patents on this Technology, Federal Court Cases, Technical Research, etc... All research is available upon request. I have an idea who was hacking my computer, and telephone, as well as the audio harassment. The only way to verify who is continuing with the Gang Stalking and Electronic Terrorism before and after Crescent City Mobile Home Park is to interrogate the individuals who has lived next door to me, tell them they were lied to and assassinated my character to get them to help them. The owner Glorie, Glories son in law, the manager Kathy, her boyfriend Bear, Joe the previous owner/leaser, A.J. and his roommate who lived across the street, as well as mobile home #20, and every neighbor since North Miami Beach can be interviewed to determine who is and was doing this. The entire back rows of Crescent City Mobile Home Park are possible witnesses to this and were possible accomplices as the pictures on my SIM card from my cell phone will show the antennas, and devices were mounted on their roofs. With an investigation, and interviews with these people the truth can be revealed. They will probably protect themselves, and the owner by not telling the truth, but I know they were responsible for starting this, and know who is doing this as they were accomplices. I have already passed Elkman's METT/SEIT micro and macro expression evaluation, and REID interviewing techniques to determine if I am telling the truth about all this through Columbia Investigations, Melinda Kidder, P.I., and the people involved in this should have to do the same thing when this is investigated for a trial in court for civil and criminal charges against these people. During my research I have discovered several organizations, one of which is called (PDEHS) Prevention and Detection of Electronic Harassment and Surveillance. They had a contact in Florida named Elvira Williams, who I called. She was recently Murdered by these Terrorists. Her story is available through PACTS International. She told me of a lady who runs a radio talk show named Ella Free. I contacted Ella and she led me to the Professionals who are now helping me; Melinda Kidder, and Dr. Hildegard Staninger. I contacted Ms. Kidder in July and made an appointment for an H-SCADA - Assessment Protocols Report on September 1st, 2017. I contacted Dr. Staninger and completed an H-SCADA Bio-Energy Field Assessment, which utilizes the report Melinda Kidder did. In November 2017 I did an FCC signal search. I had an analysis done, research, and report written on the FCC License Search. I will have a blood Test done and analysis on my skin, and hair to determine the type of Nano-Technology used in me. The analysis will show exactly who is doing this by tracing the Nanotechnology back to the Manufacturer and purchaser. Specifically, Dr. Staninger has found a Kernel through the Frequency 4827.448

which will trace back to the manufacturer, and then the purchaser of that particular Nano-Technology, and Signals. Only (2) two manufacturers make this Kernel, and through the materials used will point to one. They are continuing the assault on me with Radio Frequency signals causing electromagnetic ionic radiation to course through my body. The auditory Harassment (V2K) is still continuous. My Spine is more painful than it has ever been. My headaches are extremely painful. I see an Orthopedic Pain Manager for my spine, as well as a Neuro Surgeon, and a Neurologist for my Brain. They cannot help much, as the pain is extremely overwhelming. Dr. Staninger has finished her Report and found out that a company called Spectrum Holdings, Inc. owned by Allegro Capital Investors, LLC, and Schools, Colleges, Universities, and a Hospital is the reason I was attacked by all these people as I am sure they can attest to at Crescent City Mobile Home Park. Crescent City is in the area that Spectrum Holding Company is Licensed by the FCC to transmit using the call sign WND218 (1.000008087). They are using the frequencies outside their area, and illegal frequencies unlicensed by the FCC. Dr. Staninger who wrote the report will be able to explain this better. Dr. Staninger introduced me to an Attorney which wrote letters to the FCC on the Frequencies coming into me, and the areas of Port Richey to no Avail. It should be a simple thing for a signal intelligence officer to stop, or Jam these frequencies which are coming into my body, which are slowly Murdering me. I will be trying to hire legal counsel to stop these signals, and to financially reimburse my family and I for all our expenditures and any past and future medical expenses incurred, plus the enormous pain and suffering I have gone through. If I have to, I will represent myself, as the Bar Association, and the Medical associations are warning Attorneys, and Medical Personnel not to discuss this. I have substantial evidence, many witnesses, and am willing to eventually hire a private investigator if needed to stop this. This will take a lot of time since I depend on Social Security Disability to live. I will be Patient in my Task assigned to me by a Higher Authority than any Government in the World. In these last days we must endure, and suffer at the hand of wickedness, and evil, and wait for our God to respond. It needs to stop not only with me but with the Millions across the Globe who are being Tortured by these Terrorists daily, 24 hours a day, 7 days a week, which is why I am fighting so hard not for me only, but for all victims around the World. All Reports, Medical Reports/ Evidence, Background Searches on myself, Witness Affidavits, location of Perpetrators/Gang Stalkers at time of incident, names and addresses are easily obtained, expenditures over the last 20 years, etc... Are all Available upon request.

Over the Tampa, Florida area where I live, and over my brother's house specifically, there are Military Jets constantly spraying Chem-Trails, chemicals, and I suspect Nano-Technology (Mesogens), as the publications, and researchers have pointed out to us. Also, constant Patrolling by Military Drones, like the Predator, and with, I suspect using L3 Communication devices for spying, and extremely small drones about one-fourth the size of a predator drone in appearance of the AT-2220 drone used for Communication and Spying which I have to use Binoculars to see adequately. The AT-2220 drone was running at night without lights on as the predator drones had, spraying specific, smaller, maybe 100-yard Chem-Trails over the House. This is happening all over the world. These chem-trails are outlined in Elena Freeland's Book "Under an Ionized Sky: From Chemtrails to Space Fence Lockdown". It is a must read if you want to know what is happening to us, NOW!!! Also, Robert Duncans book "Project: Soul Catcher" both are a must read if you are concerned about your life, and the lives of your Family, and Friends.

As I have stated Eyewitness Testimony is available to the Physical Manifestation of this. The Manipulation of my head, Torso, Extremities, Eyes, and Facial Gestures, as well as substantial Sleep Deprivation all caused by the physical manipulation of my Central Nervous System, and Control through the Implanted Nano-Technology (Mesogens), and the Communication with it by Neural Electromagnetic Frequencies. I can have the Eyewitnesses send Sworn Affidavits to Attest to all of this which gives Conclusive Evidence of the severe physical damage to my Cervical and Lumbar Spines, Central (Brain & Spinal Cord) and Peripheral (Somatic & Autonomic) Nervous Systems, as well as severe damage to my Brain (Cerebral Vascular Disorders, Brain Aneurism, Cerebral Hemorrhage, Stenosis, and Deteriation of White Matter), Morgellons Disease from the Mesogens throughout my Torso, head, and Extremities, Heart, Lung, and Organ damage. All these Medical Disorders can be evidenced through my Medical Records, and Imaging records from my Doctors, and Radiologists. Caused by the Electronic Intrusion of my body by these abhorrent Crimes committed against me by these Psychopathic Terrorists, who are also committing these crimes to against Millions of Innocent Souls across this planet. The evidence of this, all my reports from Private Investigation, and Industrial Toxicologist, and Medical Records, Imaging Records, and the witnesses, all people, Law Enforcement officers, Paramedics, Doctors, and Pharmacist have been described in this Testimony. Also there is evidence from Military Intelligence officers, and Government Agency Intelligence Officers, Law Enforcement Officials, well renowned Scientists, Doctors, Attorneys, American Diplomats, American Embassy Workers, United States Patents, Inventors, well

known Politicians, Security Personnel, Neuro Scientists, NASA Scientists, Government Agency Whistle Blowers, Federal court rulings, and United States Supreme Court Rulings on the website targetedevidence.com put together by the Commissioners, and Directors at Targeted Justice, all attesting to the fact that this technology is there, and is being used against the United States Citizens, and against the Citizens of all Countries in the World.
